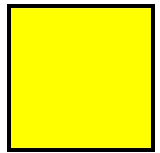

Further, I understand and agree that in completing and signing this agreement between myself and Patriot Dive Club, I am responsible for payment, in full, of tuition and all other required fees associated with the club as outlined on the Patriot Dive Club website during the above stated "session", even if my child does not complete the "session" for any reason including, but not limited to, injury, illness, lack of enthusiasm, relocation, changing programs, etc. Additionally, I am aware of and accept all travel responsibilities associated with the sport of diving for practice and competition through the course of a "season" at the level for which my son/daughter is participating with Patriot Dive Club. _____ **(initial)**

Waiver and Release of Liability

The undersigned agrees and understands the following in consideration of participation in the sport of diving as related to practice, athletic training, competition and all related activities:

1. Agree that prior to participating, or in the case of a minor participant, the parent(s) or legal guardian(s) will instruct the minor participant that prior to participation, he or she should inspect the facilities and equipment to be used, and if the participant believes anything is unsafe, he or she should immediately advise his or her coach or supervisor of such condition(s) and refuse to participate. _____ **(initial)**
2. Acknowledge and fully understand that inherent risk(s) exist from the participation of such activity including serious injury resulting in permanent disability and death. I assume all foregoing risks and accept responsibility for all damages following any and all injury including permanent disability or death. _____ **(initial)**
3. Understand that the use of illegal drugs is strictly forbidden. Further, prescription and non-prescription drugs may not be administered by any staff members of the Patriot Dive Club, the Aquatic and Fitness Center, George Mason University or its affiliates. In the event that prescription or non-prescription drugs are to be taken by the participant during any related activities, at the site of George Mason University or other activity related facilities, the participant shall only have in their possession the recommended dosage in its original container. _____ **(initial)**

It is assumed that all participants are in good physical condition and that a physician's approval has been granted for participation in all related activities. To the best of my knowledge, there are no physical or other conditions, which will interfere with participation in any related activities.
